## MANAGER'S COMMENTS

The FBMKLCI Index rose 1.3% M-o-M to end May 24 at 1,597 pts, outperforming both the MSCI Emerging Market Index and the MSCI All Country Asia ex-Japan Index, KLCI also outperformed all other ASEAN markets (Malaysia, Indonesia, Singapore, and Thailand). The three best-performing indices on a M-o-M basis were Utilities, Healthcare and Industrial production & Services.

Out of Bursa Malaysia's 13 sectorial indices, 10 also posted gains, with Technology, Construction and Property were the top performing sectors. On the side note, Plantation and Energy were the main laggards.
